25. 34. To provide self finance and promote self help group for providing service for farmer and poor.

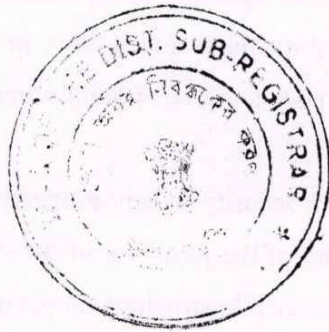



- b) The SETTLOR and the parties of the Second Part will be the First Trustees and they shall automatically form the Board of Trustees.
- c) The Trustees shall at each meeting appoint one of their members present to be the president of the meeting.
- d) The annual meeting of the Board shall be once of each year. The Board may also meet on requisition by any Trustee. All decisions of the Board shall be by simple majority unless otherwise provided.
- e) The trustees appointed shall hold office for a period of Five years and are eligible for reappointment.
- f) Any trustee may if he/she do desires, resign his/her trusteeship even before the expiry of term of trusteeship and the resignation would be effective only from the date of acceptable of such resignation by the Board of Trustees.
- g) The office of a trustee will automatically become vacant on the occurring of any of the following events : (1) Death of trustee (2) bankruptcy of the trustee (3) conviction of the trustee for a criminal offence under the criminal penal code. c) **TREASURER:**

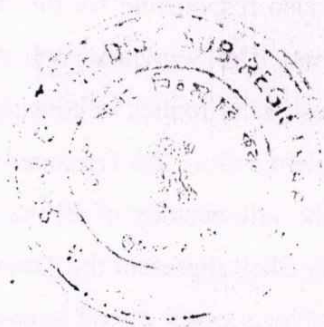

VII. MEETING OF THE BOARD OF TRUSTEES:

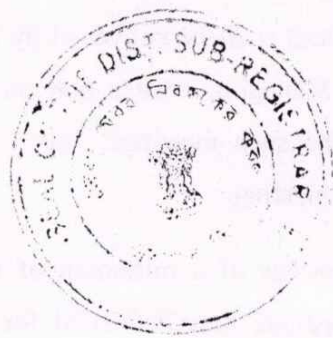
The Board of Trustees should meet at least once in every calendar year and may meet more often when required.

VIII. BANK ACCOUNT :





Notwithstanding the powers vested with the Trustees under the preceding clause, no part of the income of the Trust shall benefit directly or indirectly the trustees and no part of the income of the property of the Trust shall be used or applied directly or indirectly for the benefit of:

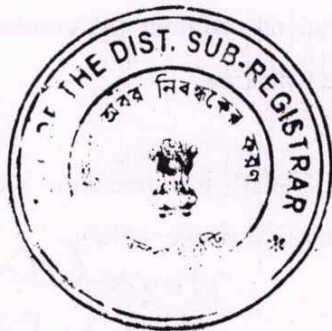
